### **PRELIMINARY FORM DIRECTIONS**

The Preliminary Form identifies your descendency line from Philippe de Lanoy through one of his sons or daughters. It also tracks your line through the pages of the GHAAHD up to the late 1890's and gives an overall relationship of your line to others in this DELANO Genealogy. Your additional information about your line of descent beyond the 1890's is a most important contribution to our goal of updating the GHAAHD.

#### **GHAAHD Overview**

Major Joel Andrew Delano's THE DELANO GENEALOGY From 1621 to 1899 is the second book of the GHAAHD and starts on page 95. Pages 99 through 104 cite details about Philippe's wives and children and give some early genealogical information about his daughters. Pages 105 through 518 give detailed genealogical information that was known about the families of Philippe's sons to 1899.

Part I, pages 105 through 151, is the descendants of the first son Philip Delano Jr.

Part II, pages 153 through 281, is the descendants of the second son Dr. Thomas Delano. Please note that Dr. Thomas married Rebecca Alden not Mary Alden as stated on page 145.

Part III, pages 283 through 292, is all the information that was known of the descendants of the third son John Delano.

Part IV, pages 293 through 506, is the descendants of the fourth son Lt. Jonathan Delano.

Part V, pages 507 through 518, is all the information that was known of the descendants of fifth son Samuel Delano.

Part VI, pages 519 through 532, is information on "Unknown Branches."

Part VII, pages 533 through 535, contains a listing of certain war records of surnamed DELANOs followed by a circular and addenda for August and September 1899 on pages 536 & 537.

Pages 538 through 542 are allocated for individual family genealogical records.

The General Index, pages 543 through 560 containing almost all of the surnames in the GHAAHD, is a most powerful tool in finding where a descendency line fits in the DELANO Genealogy. The DELANO surname is indexed by first names.

Notes and discovered errors are identified on pages 560 and 561.

#### ***Directions***

It has been over 100 years since the GHAAHD was published. Therefore you will probably have between three and six generations of your line of descent that are not included in the genealogy. You must determine these generations to reach back to the late 1800's. Obviously, if the DELANO surname is not included in these generations you will have to trace back all the generations of your line to your DELANO surnamed descendant.

Find your DELANO descendant in the GHAAHD and then follow it back to Philippe de Lanoy.

List all the generations on the Preliminary Form including the page numbers of those in the GHAAHD.
