# Jonathan and Mary (Delano) Dunham Genealogy Found

Our genealogist, Muriel Cushing, reports that she has found a copy of the genealogy of Jonathan Dunham and Mary Delano in the New England Historical and Genealogical Library in Boston. As you may recall Mary Delano was the first child of Philippe and Hester DE LA NOYE. In News Letter #3 (June 92) we stated that according to the GHAAHD there is no record of any children born from the marriage of Jonathan and Mary (Delano) Dunham. According to the genealogy Muriel found, there was one child born from that marriage as follows:

"Daniel, b. 1656"; md. "Rebecca Norton. Lived in Edgarstown Martha's Vineyard."

It is believed Mary died in 1656 perhaps as a result of child birth.

# Proclamation Features in ALDEN KINDRED Newsletter

As reported in our News Letter #4 (Sept. 1992) a Proclamation of Friendship and Recognition was given to the ALDEN KINDRED on 1 August 1992 when the DELANO KINDRED Annual Meeting and Reunion coincided with the ALDEN KINDRED'S Annual Meeting. The ALDEN KINDRED Annual Newsletter featured a photograph with the following caption, "The above certificate was presented to the Alden Kindred of American, Inc. by our Delano 'neighbors' during a 'formal visit' during our 1992 Annual Meeting. The Delano Kindred, Incorporated is a newly formed family organization for the descendants of Philippe DeLaNoye (Delano) who acquired land next to the Alden Homestead and settled his family there in 1632. The Delano's held their first Annual Meeting on August 1st, 1992, coinciding with our own meeting."

# DELANO FAMILY BRANCHES John Delano Branch

Continuing with our genealogical outlines we will cover the John Delano Branch. Most of this information was compiled by our genealogist, Muriel C. Cushing.

John Delano b. Duxbury 1644, the third son and the fifth child of Philippe and Hester DE LA NOYE, d. Duxbury after 1719. John md. Duxbury ca. 1680 Mary Weston, dau. of Edmund Weston and an unknown wife. (Somesources suggest she was a Delano.) Mary Weston's date of birth, death, and marriage are unknown; however, as she was married by the year her father named her in his will, 1686, she was probably born some twenty or more years earlier. In the 1887 Article (Desc. of Edmund Weston) she is placed between brothers Elnathan and Edmund, so it would seem that 1658-9 would be a reasonable time period.

They had six children all born in Duxbury as follows:

1st Israel, b. 1679; d. unmd. 1704.

2nd Lydia, b. ca. March 1680; d. 23/24 Nov. 1763, aged 83y,8m. She md. 25 May 1704, Josiah Soule.

3rd Mary, b. ca. 1683; d. Dartmouth 29 April 1716, age 33. She md. Duxbury 8 Feb. 1709/10, Jabez Delano.

4th Nathaniel, b. 1685; d. before 29 April 1731. He md. Duxbury 24 Oct. 1714, Mercy Bonney.

5th Mercy, b. 1687; d. prob. Dartmouth (date unk). She md. Duxbury 25 Nov. 1713, William Spooner.

6th John, b. 11 Oct. 1689; d. ca 1741. He md. Duxbury 2 July 1718, Sarah Cole.

Windsor mentions John in public transaction; in 1690 he lived on the north side of the path which led from the Mill to South River and his name appears among those who leased the commons. In 1703, measures were about to be taken by the town for a division of the commons. On 12 Sept. 1707, it was voted to every householder, 20 acres, & on 5 June 1710 it was divided between John Delano and 165 others. Among the other 165 were also many other Delano and allied families.

On 24 Feb. 1719, John Delano, Sr., cordwainer\*, sold to his son John Delano, Jr. "the farm where he dwells in Duxbury". Mary Delano witnessed the deed. John Delano, Sr. sold to Thomas Delano, Sr. & to Joshua Delano, "3 acres of upland given by his father Philip deceased, and part of the farm where he dwelt with us." Later owned by Thomas Delano.

\* A cordwainer is a worker of cordovan leather or a shoemaker.

#### CORRECTION

Our genealogist, Muriel Cushing, informs us that we made an error in our last News Letter #5 (Dec 1992) and in our previous News Letter #2 (April 1992) DELANO Family Branch features when we said that Dr. Thomas Delano's second marriage on 24 Oct. 1699 was to Hannah Bartlett (widow of Ebenezer Bartlett). Muriel reports that it was Dr. Thomas Delano's son Thomas Jr., b. 12 Nov. 1668/9 who married Hannah (Bryant) Bartlett on that date (See Mayflower Births and Deaths Vol. 1:50). Muriel reports that Dr. Thomas Delano had a second marriage but the name of his second wife is still unproven. We thank Muriel for bringing the error to our attention. We note that the GHAAHD is in error on this point. See GHAAHD pg. 154 and pg. 181.

6th Mary, b. ca 1679; d. Duxbury 7 Nov 1756; age 76; unmd.

7th Sarah, b. 1682; d. prob. Middleboro after 15 May 1746; md. ? Plymouth John Drew, son of John & Hannah (Churchill) Drew. 8th Ruth, b. 1684; d.Middleboro ? after 5 Oct. 1722; md. as his 2nd wife Samuel Drew, son of John & Hannah (Churchill) Drew.

9th Joseph, b. 1 Sep. 1685; d. Duxbury 22 May 1770; md. Marshfield, Hannah (Bartlett) Arnold; dau. of Samuel & Hannah (Pabodie) Bartlett & widow of Benjamin Arnold.

# The Towns of Delano in North America: Then and Now

On page 4 of the GHAAHD there is a list of the towns named DELANO known to have existed in Canada and the United States in 1899. Since then some towns have disappeared through name changes and population shifts and other DELANO towns have come into existence.

Recently we were pleased to have forwarded to us a letter from Mrs. Helen C. Tullock of Delano, TN giving information about that town and how its name became Delano. Because of her letter we have attempted to update the list with information we have obtained from various sources.

Page 4 of the GHAAHD lists eight towns of Delano in North America and one county in South Dakota as follows:

Delano in Ontario, Canada; Delano, Kern County, CA, population (1890)–401; Delano in Winnebago County, IA; Delano in Wright County, Minnesota, population 857; Delano in Schuylkill County, PA; Delano in Butler County, PA, population 182; Delano Junction in PA, population 65; Delano or DeLano in Pierce County, Washington.

Using current, but limited, sources we tried to determine where the existing DELANO towns and cited were located. Our sources for researching Canada were more limited since we could not gain access to a Canadian Postal Code Book. Wesearched our road map of Ontario for any indication of the town of Delano and found none. We would appreciate information about this town. Other Delano towns we could not find were Delano in Winnebago County, IA; Delano, Butler County, PA; Delano Junction, PA; and Delano, Pierce County, WA (although we found two other Delano towns in that state).

Today there is no <u>Delano County</u> in South Dakota. The GHAAHD suggests that it was formed in 1875. Since SD gained statehood in 1889, it is presumed that Delano County was in the southern portion of the Dakota Territory created in 1861.

Some years before 1978 there was a town of <u>Delano, KS</u> which had its own U.S. Zip Code. By January 1978 it had disappeared. It was understood to have been located on the western side of Wichita KS and was probably absorbed by the larger city.

In this issue we feature <u>Delano, TN</u> 37325. This very small town (located to the west of US 411 about 20 miles NE of Cleveland TN) has a population under 500. Mrs. Tullock of Delano TN writes "According to local tradition Franklin Delano Roosevelt was a good friend of the Wetmore family. The Wetmores lived in New York, but owned hundreds of acres of land in this area. Their property was called Savannah Farms.

Some think his friendship with the Wetmores was what brought your relative, Franklin, to this area. He was traveling in his private car, and it was parked on a siding near the place now called Delano, a small village with one store, a post office and at that time there was a lumber mill. Wetmore joins Delano so closely it is hard to tell where one ends and the other begins. Wetmore had its own train station at that time, and the lines that run to it were completely different from the line on which Franklin was parked. He asked the

name of the place where he was parked and was told it was Pendergast. It seems that Pendergast may have been a political enemy, or at least, a man for whom he had little respect" (probably "Big Tom" Pendergast, the Democratic party boss of Kansas City). "He said, 'Oh no, we'll have to change that name.' When he returned to his home, he requested a name change for Pendergast, and the new name was Delano."

Mrs. Tullock also writes "Delano is located in a county with some of the most beautiful scenery I have ever seen. It will be the setting of the white water rafting during the 1996 Olympics.... We enjoy the nature trails... the waterfalls, the lively wild flowers, and many more things.... If some of your Delano relatives are outdoorsman or history buffs they might want to come to this area sometime."

The 7th and 8th grade students of Delano Elementary School compiled a history of Delano, TN in March 1986.

Again, we would like to emphasize our interest in any information about DELANO towns, landmarks and other items of Delano historical interest. # Color Photographs of the GHAAHD Coat of Arms

In the original GHAAHD (1899) there was a color print of figure 1—the complete achievement of the house of Delano [Lannoy and Barbancon]. This color (presumably a lithograph) is missing from many of the original GHAAHD's and is only rendered in black and white in the copy produced by Higginson Books. Nancy Delano has made an 8x10 color photograph of an original Coat of Arms from one of the GHAAHD's in the Duxbury area. If you desire a photographic copy of this Coat of Arms, write to Nancy B. Our first query is from Ivan S. Irwin of Mound City, KS. Mr. Irwin would like any information concerning Betty Delano Rouse. She was born on 3 April 1812 in Rhode Island. She married Albert Weaver Lumbard on 6 November 1831. They had 3 children. She died on 1 September 1938 in Brimfield, MA and is buried there. He has been unable to obtain certificate data from counties, etc. in Rhode Island. We know there were Rouses that settled in the Marshfield MA area earlier than 1812. The only Rouse wewere able to find in the GHAAHD was on pg. 531 concerning a Rouse Delano from an unknown Delano line.

# Official Genealogical Reference Adopted by the DELANO KINDRED Board

The Genealogy, History, and Alliances of the American House of Delano 1621 to 1899 (New York, 1989) compiled by Major Joel Andrew Delano and Arranged by Mortimer Delano de Lannoy (referred to by the acronym GHAAHD) is the most comprehensive Delano family history known to officers and directors of the DELANO KINDRED. Although known to have "alarge number of errors" and a somewhat "awkward manner of presentation," its 561 pages of information, which include a detailed general index, have proved to be a valuable source for determining lineage of a DELANO surnamed, descendant/ancestor born before 1895 to 1899.

The GHAAHD is arranged in two books. The first book contains a history and heraldry of the Maison de Franchimont and de Lannoy from 476 to 1621 as well as some details of the DELANO de LANNOY coat-of-arms including the motto "Bonnes Nouvelles." The second book is The DELANO Genealogy from 1621 to 1899.

Because of its comprehensive documentation, the DELANO KINDRED Board has adopted the GHAAHD as the major genealogical source for this Society, notwithstanding its errors and arrangement. One of the goals of the Society is to correct and update this reference.

There were only 400 original copies of the GHAAHD printed in 1899. However, Higginson Books, Derby Square, Salem, MA 01970, phone (508)745-7170, has good copies of the original with illustrations. The sale price of the GHAAHD is \$50.00 (US) plus

postage—a savings of 30% under the catalogue price. If you mention the DELANO KINDRED News Letter, Higginson Books will make the sale price available to you after the sale ends. The normal contact at Higginson is Emily Wheeldon, who is at their office Tuesday-Friday.

# Old Naming Pattern

The following old naming pattern was a common practice in some families. Though not an invariant tradition, it may give a due about the name of grandparents whose names are often so elusive in genealogical research.

The first son was named after the father's father.

The second son was named after the mother's father.

The third son was named after the father.

The fourth son was named after the father's eldest brother.

The first daughter was named after the mother's mother.

The second daughter was named after the father's mother.

The third daughter was named after the mother.

The fourth daughter was named after the mother's eldest sister.

It was also a common practice, especially among Quaker families, to give their children Biblical names.
